I. Based on information provided in lectures, be prepared to answer and discuss the following questions about the **Executive Branch** of the US government.

- 1. What does the position of commander-in-chief of the armed forces mean?
- 2. Explain the differences in the functions of Chief Executive and Head of State?
- 3. How is the President's cabinet selected and approved?
- 4. In your opinion, when should a President use his power of pardon?
- 5. How long may a US president serve in office? In your opinion, is this too long, too short, or about right? Why?
- 6. What is the age requirement for someone to be elected president? Why is there an age requirement, and do you agree with this particular age? Is it too old or young, in your opinion?
- 7. By US law, a president must have been born in the US. Why do you think this law was written? Do you agree with it?
- 8. What are the advantages and disadvantages of having a strong Presidency/Executive?
- 9. What is a presidential veto and how does it work in the US? Is this a good idea?

## **Powers of the President of the United States**

#### Head of State

Represents the Nation at home and abroad

#### Head of Government

The President is responsible for the execution and enforcement of the laws created by Congress.

The President has the power either to sign legislation into law or to veto bills enacted by Congress, although Congress may override a veto with a twothirds vote of both houses.

The President conducts diplomacy with other nations.

The President has power to extend pardons and clemencies for **federal** crimes.

Must be at least 35 years of age Must be a natural born citizen Must have lived in the United States for at least 14 years
